| Our waiting list is for serious Purchasers only. A non-refundable deposit gets you on the list. Space is filled on a first come, first served basis. Being on the waiting list ensures you are getting the right quality and sex that you are looking for. |
| Guardian Boerboels must be notified in writing if the purchaser decides not to follow through with the purchase of the puppy. The deposit may, under certain circumstances, be transferred to another litter. This is at the sole discretion of the seller. However, please note that if any upcoming litter has previous deposits, those previous deposits will have priority. |
| Guardian Boerboels will do their best to fulfill the Purchaser's request for a puppy; however, the Purchaser understands the Seller has no control over how many puppies will be in the litter and/or how many of each sex and/or color will be whelped. |
| In the event a planned breeding fails or is late due to the female not starting her heat cycle on time, the deposit may be transferred to the next breeding of the same pairing (Sire/Dam (usually in 5-6 months)) or another litter (if available), agreed upon by both the Seller and Purchaser. Under any circumstance Deposits are not refundable. |
| Purchaser and Guardian Boerboels acknowledge that no guarantees can be made of the absolute future quality of the desired puppy. There is always the possibility that a puppy will not reach its full expected potential. |
| In the event a puppy of requested sex or quality is not born, the deposit will be transferred to the next litter. We will do our best to get the color of your preference, but we make no guarantee on color. |
| Once the puppy reaches 6 weeks of age, the final payment of \$ + Shipping is due. The payment must be in the form of cash, money order, cashier's check, Walmart to Walmart or direct bank transfer or through the Good Dog Secure Payment Portal at https://pay.gooddog.com/guardian-boerboels . Good Dog's secure online NO-FEE payment method. |
| Buyers have a no-fee option through the Good Dog Payment Portal: Buyers have a choice when making their final 'Dog Payment' to pay a small fee to receive 'Protection and Support', which includes access to Good Dog's Puppy Training Program (\$235 value), we strongly recommend taking advantage of this program. Or buyers can choose to pay with zero fees. |

What you get from Good Dog's Puppy Training Program:

Make secure online payment through Good Dog Payment Portal at https://pay.gooddog.com/guardian-boerboels.

You may also pay over Facebook Messenger (which is a direct bank to bank transfer), Venmo, Zelle (Most banks offer Zelle now), Apple Pay, Google Pay or PayPal to christina.johngraff@gmail.com. When using PayPal, if selecting the 'Friends and Family' option there is no fee to the purchaser, as long as it is sent from a PayPal with a linked bank account. If purchaser uses PayPal with a credit card, the purchasers' fee is 3.6%. We DO NOT accept PayPal sent via 'Goods or Services' and monies will be refunded. The Purchaser will be responsible for any fees.

Guardian Boerboels allows the Purchaser to make payments if they wish, as long as the Purchaser understands; all payments made are non-refundable, the puppy must be paid-in-full, including shipping by 6 weeks of age, no later. If final payment is not received by 7 weeks of age, the contract will become null and void and all payments received will be forfeited. If for any reason you decided to cancel your pup all payments the Purchaser paid to Guardian Boerboels is forfeited by the Purchaser.

All payments must clear before the puppy is released. The puppy will be released at a minimum of 8 weeks old. Along with the final payment + shipping (if applicable), the below named purchaser MUST sign the Guardian Boerboels Purchase Agreement.

Because of demand, we prefer that the puppy be placed in their new home at 8 weeks of age. If Purchaser is unable to acquire the Puppy at 8 weeks old due to vacation or other reasons, there will be a boarding fee of \$15.00 per day, which must be paid in full prior to release of the puppy. Any puppy not acquired by 10 weeks of age will result in your deposit being forfeited.

This is a binding agreement and if the below named purchaser breaches this contract, the deposit and any other funds received by Guardian Boerboels will be forfeited.

By signing this contract below, the purchaser understands that the **deposit is non-refundable and will be forfeited if purchaser decides not to take delivery of the puppy as agreed.** The purchaser also understands and agrees that the final payment is due when the puppy reaches 6 weeks of age, no longer.
